Troubleshooting

Ethical approval

1 **The MRI project should be approved by an ethical committee before running the pilot.**

Approval from the ethical committee (EC) may take some time; therefore, it is the first step in this protocol. Make sure to read the following steps from this section ("Ethical approval") before applying for ethical approval, as it will help you to include all the necessary information in your EC application.

External researchers starting a project at the 3T MRI scanner of the Spinoza Centre UvA REC may also request EC approval using the Ethical Committee of Psychology of the UvA. Send an email to lab-fmg@uva.nl and t.beemsterboer@uva.nl to request an account for the website for requesting EC approval. Mention in your email that you want to request EC approval for a MRI project at the Spinoza Centre UvA REC, your name, university, and department.

Once you have an account, go to the website: <https://www.lab.uva.nl/lab>. Click in the upper right corner on 'Onderzoeker'. Log in and follow the instructions.

2 **Rules and regulations for lab research**


Make sure that all researchers and research assistants of the project, are familiar with the Rules and procedures for lab research (see **Rules and Regulations Lab Research**).

3 **Screening, information for participants and GP informed consent**

In order to obtain ethical approval you need to inform the Ethical Committee or Medical Ethical Committee about the MRI-safety screening procedure and "Incidental findings" procedure. In addition, you need to supply an information brochure about MRI-research that you will give to your participants.

You can find these files attached to this step in both Dutch and English. This also includes an explanation of the **incidental findings procedure** one needs to follow at the Spinoza REC ("description of anomaly procedure"). Include these files to your Ethical Approval.

If you plan on sharing your anonymized data with others, make sure to include this in your EC application. The template "information letter" (see previous step) includes an example paragraph that allows you to do so. When using the centre's preprocessing/QC pipeline, your data will be properly formatted to be uploaded to the **openneuro** data repository.

5 Screening

Subjects need to be screened before cooperating in MRI experiments. MRI is a perfectly harmless method for examining the brain, but the static magnetic field attracts metal objects. Therefore, the MR-operator needs to preclude the possibility that participants have any metal objects inside or on their bodies. The screeningform is created with consultation of the radiology department of the AMC. There is also a document provided by the Spinoza Centre REC-L where each question of the screening form is explained. We advise all researchers to pre-screen their subjects to prevent, as much as possible, to have participants showing up and being rejected for the MRI scan. Keep in mind that the MR-operator has final responsibility for the screening en safety of the participant.

MRI screening forms are stored safely at the Spinoza REC. After a scan session, the researcher or MRoperator, has to deposit the MRScreening in the mailbox. The mailbox is located in the MR operator room.

6 Insurance

The liability insurance of the UvA offers, within the framework of the policy conditions of the insurance, coverage for (non invasive) research provided the Medical Research Act (WMO) set no specific requirements regarding insurance for participants. This coverage includes damage to the equipment and damage to / from the subject and the experimenters. This coverage applies to researchers of the University of Amsterdam and visiting researchers at the University of Amsterdam (employees of other universities and employees of scientific institutes like the NIN). In addition, this insurance also applies for

external (possibly commercial) research as long as this is conducted by employees of the UvA. For every claim there is a deductible for the institution of the researcher of 25,000 euros. If however there is an indication of WMO, the responsible investigator must get a separate insurance.

Liability

The Spinoza Centre REC-L advises all users to have a personal liability insurance.

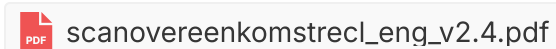
7 The PI of the MRI project completes the User Agreement.

Quality control of scanner

8 Weekly and monthly quality control

The Spinoza Centre REC-L does a weekly and monthly quality control of the MR scanner to maintain good quality of the scans. If any irregularities are noticed they are solved by the Spinoza Centre REC-L, and if necessary by Philips Healthcare. If we find that it may have influenced previous scans sessions, the Spinoza Centre REC-L contacts the researcher about this. During the weekly check we perform the Philips system wide quick check, make a recording of the basic sequences with a phantom (and perform subsequent data-analysis to determine the behavior of the sequences) and run through a checklist to ensure that the stimulus material and the rest of the center are in working order. During the monthly check we recalibrate the system to ensure that the operation specs are always close to the optimal. We further perform more complete diagnostics, for instance on each of the 32 channels of the headcoil.

9 Apply for a calpendo User Account.

The *PI and all other researchers, research assistants and interns* of the project should apply for a user account in Calpendo.

Go to the link <https://spinozarec.calpendo.com>.

Calpendo is the Calendar and user registration system used by Spinoza REC. Apart from booking registrations, Spinoza REC uses Calpendo to register Scan, Safety, Eyelink, EEG, GSR, EMG, fear conditioning and TMS certification, badges and BHV.

10 The PI of the project applies for a project in Calpendo.

After the user accounts have been approved, the PI of the project can apply for a project in Calpendo.

Please follow the following workflow to request the project:

- In Calpendo press Projects, **Create Project**;
- Choose for **Project Code** the unique short name for your experiment as specified in the contract;
- **Upload the protocol** as known by the Ethics Committee, at Protocol
- In **Project Resource settings** choose the Resources needed for the project.
Include the number of hours per resource and the costs per hour for use of the MRI scanner as specified in the contract.
- **Users**: add all users of the project who have permission to manage MRI bookings for the project.
- **Safety**: set true at the stimulus equipment that will be used for the project.
Note that the researcher of the project needs a certificate for using the Eyetracker, TMS, EGI and electrical stimulator.

13 **Schedule an introduction meeting.**

Spinoza REC offers the possibility to have a meeting with Tinka Beemsterboer, Lukas Snoek and Steven Scholte to discuss the project. To set up a meeting, email Tinka Beemsterboer (t.beemsterboer@uva.nl).

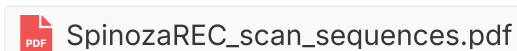
Examples of what to discuss during the intro meeting

- Choice of scan sequences
- Set-up of the experiment
- Information about our automated preprocessing and quality control pipelines (see also step 18)
- MR-course for the MR-operator
- Safety certification of assisting researchers
- Planning of the project
- Access to the Spinoza Centre (*all researchers and research assistants get access to the Spinoza Centre, either on your UvA card or a badge provided by the Spinoza Centre REC*).
- Use of Spinoza REC lockers
- Expectations and questions from both parties

We strongly advice to make use of this oppurtunity and prepare accordingly, because it is our experience that small details, which are easily overlooked, often result in failed pilots and the loss of valuable scanning time. The rest of this protocol gives you more information about this matters.

Scan sequences

- 14 Below, you can download an overview of our standard set of scan sequences. While the document is 'work in progress', we recommend to take a look at it before the introduction meeting.



Experimental paradigm/stimulus programming

15 **Make sure to have a working paradigm that waits for the first start pulse of the scanner**

With each BOLD-MRI volume (excluding dummy scans), a trigger is sent to the stimulus computer. These enter the system as the letter **t** (a keyboard response). Make sure your paradigm doesn't start until it registers the first keyboard **t** response.

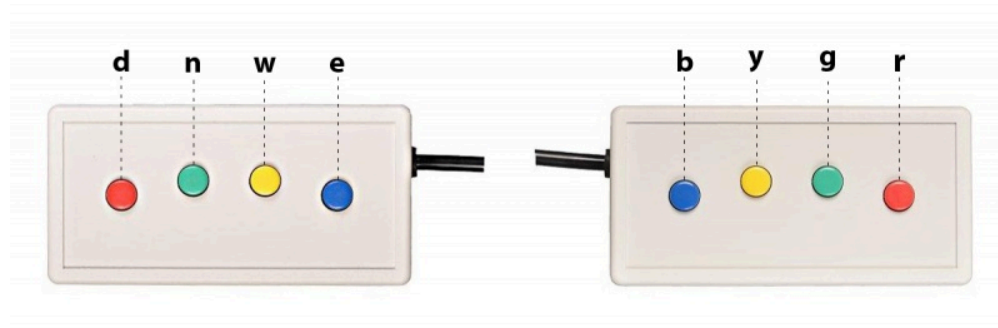
The following stimulus programs are installed on our stimulus-computer:

- Presentation (for which we offer technical support)
- E-Prime
- Matlab (Psychtoolbox)
- PsychoPy
- (For other programs, contact Tinka Beemsterboer for the possibilities)

16 **Make sure your experiment interfaces properly with the response buttons of our button boxes.**

Check the image below for the mapping of the buttons to the registered responses on the stimulus-computer (e.g., a response with the left index finger of the left hand will be registered as a keyboard **e** response).

We also offer the use of the MRI compatible mouse and joystick. Let us know when you want to use these.



17 **Decide on whether to use additional stimulus equipment.**

Note: users are not allowed to change the stimulus set-up of the Spinoza Centre REC without approval from Spinoza staff.



If you think additional stimulus equipment or other programs are necessary for your experiment, please let us know.

For example:

- Auditory stimuli;
- PPU (cardiac signal) and respiratory belt. This is free of charge and it is not necessary to book extra time for this;
- Eye tracker;
- EEG;
- Skin conductance;
- EMG;
- Electro-stimulator device (pain stimulation)
- TMS

Ideally, mention if you plan on using extra stimulus equipment during the introduction meeting.

For the use of additional equipment additional training is required. This is mostly done in short courses, depending on the experience of the user. The user may very well be an experienced user already, in this case we only verify correct handling of the equipment and some MRI specifics. This “exam” can be done within an hour and there are no additional costs. To get experience using the equipment you may consider consulting an experienced fellow researcher.

There are no additional costs for using GSR, EMG, EyeTracker, Electrical stimulation, ECG, PPU, Respiratory belt and auditory system. Electrodes and other accessories are provided and also without additional costs.

The additional costs for the use of EEG are 50/hr if you need to use a cap from the Spinoza Center.

For TMS this still needs to be determined, contact Steven Scholte for more information.

We are happy to give you advice and/or more information about the additional equipment.

Preprocessing/QC service

18 **Decide on whether to use our Preprocessing Pipeline and QC pipeline offered by Spinoza REC**

We offer automatic BIDS-conversion, preprocessing, and quality control of your data.

*Info about **BIDS**-format and the Spinoza BIDS converter tool*

In order to run the QC and/or preprocessing pipelines (**MRIQC** and **FMripREP**, respectively), we need to convert the raw data from the scanner to the **BIDS**-format. The

BIDS-format is a specification of the format and naming of files associated with neuroimaging experiments. We have developed a tool (**[bidsify](#)**) that is able to automatically convert MRI data and associated files from our scanner to the BIDS-format, such that we can use the aforementioned pipelines.

Our BIDS-conversion tool works, in principle, with all standard scans in our repository (i.e., it doesn't work with custom sequences) *given that you've given the correct names to your scans*. Also, unfortunately, our BIDS-conversion tool *does not work with scans that are manually stopped by the MR-operator* (which is sometimes done in experimenting with variable stimulus/task timing). So, if your scans need to be stopped manually, you cannot use the preprocessing/QC services.

During the pilot, the MR-operator will help you with the correct naming, but the responsibility for correct naming lies, ultimately, with the researcher.

19 **Decide on the specific scan sequences that you want to run.**

We advise you decide on which and how many sequences you want to run, including structural scans (T1-weighted, T2-weighted), functional scans (EPI-based), diffusion-based (DWI) scans, and fieldmap scans (e.g., B0-based phase-difference fieldmaps or 'top-up' fieldmaps). Also, calculate the duration of the scans with regard to the duration of your paradigm/tasks.

If you intend to use other sequences than the basic sequences, let us know in time so we can set this up before the pilot (ideally, in the introduction meeting).

20 **Folder structure in BIDS (in case you want to use the automated preprocessing or Quality Control Pipeline).**

Not using the preprocessing of qc pipeline? Skip this step!

Every day at 11pm, we will check the export folders (fMRI Projects or Dropbox) corresponding to the currently active experiments at our centre. If we find 'new' data, we will copy it to our server and start BIDS-conversion and QC (and, if desired, preprocessing). In order for our tools to 'find' your data, we expect it to be organized in a particular way. In all cases, we expect that you export the data to a subfolder in your export folder called 'raw'. Then, we expect each subject to get its own subdirectory in the 'raw' directory, with the subject name as folder-name (e.g., *sub-01COM*). Optionally, if you have multiple sessions, each session will get its own subdirectory in the subject-directory, with the session name as folder-name (e.g., *ses-01*). For example, suppose you plan to scan 20 subjects, each two sessions, and your export folder is called 'fMRI Project ExampleExp'. You should export the data from subject *sub-01_ses_01* to the following location:

If you don't have multiple sessions, you may export all files directly to the subject-directory, e.g.:

Note that you cannot create directories within your export folder from the scan-computer; you can use the 'scan-assistant' computer (right of the scan-computer) for that. Then, after 24 hours or so (depending on the desired parameters used in the preprocessing pipeline), we will copy the BIDS-converted data, quality control results, and preprocessing results to your export folder, using the following structure:

All "BIDSified" data will be stored in a directory called "bids". Moreover, this directory contains a subdirectory called "derivatives", that contains all "derived" results from the BIDS-data, including the output from the preprocessing pipeline ("fmripred", and optionally "freesurfer") and QC-pipeline ("mriqc"). The html-files contain information and visualizations of the intermediate steps and results from the preprocessing and QC pipelines. You can simply double-click these files to open them in your default browser. The *group_*.html* files contain useful plots with different QC-metrics of all your participants so far, which is a great way to easily spot outliers (e.g., participants with a lot of motion).

Estimate scanning time

21 **Estimate the time needed for one participant.**

Below you find an approximation of the scan time needed per participant depending on the stimulus setup; note that the duration of the scans should include communication to the participant, set up of the scans, shimming and survey scan. Furthermore the time needed per participant is dependent on the type of participants and the experience of the researcher.

- Simple protocol, possibly including PPU and Resp: duration of the scans + 10 minutes;
- With GSR or EMG measurements: duration of the scans + 20 minutes;
- With eye tracker measurements: duration of the scans + 20 minutes.

Of course, this estimation may be adjusted after the pilot or during your experiment.

Schedule and prepare a pilot

22 We strongly recommend running a pilot session with an experienced subject. Please email Tinka to schedule

In the protocol referenced at the very last step of this document, we'll outline a checklist with things to think about before running a pilot session.
